



LYC CLASSIC COMPENSATION PLAN

MEMBER – Completes an Application Form and pays the one-time Enrollment Fee of \$20. A Member can purchase all LYC products at Member prices.

DIRECTOR – To become a Director, you must do the following:

1. Complete an Application Form and pay the Enrollment Fee of \$20
2. Place an order for a minimum of \$100
3. Complete the Autoship Application Form for the \$40 monthly Minimum Wholesale Volume purchase that will become active the month following your enrollment. When signing the Autoship Application, a Director agrees to remain on the Autoship Program a minimum of two months in succession.

To maintain your Active Director status and to qualify to receive your Bonus payments, you must remain on the \$40 monthly Autoship Program.

Your membership becomes official when the Application has been received and processed at Corporate Headquarters. You will immediately be assigned an ID# which you should use with all future communications with LYC Classic.

BONUS PAYOUTS – Bonuses are paid monthly on or before the 20th of the month following the Director's activity. The only qualification to receive your Bonuses through your entire 5 Levels is for you to be on the monthly Autoship Program for the \$40 personal Wholesale Volume purchase.

- 1st Level Payout – 10%**
- 2nd Level Payout – 10%**
- 3rd Level Payout – 10%**
- 4th Level Payout – 5%**
- 5th Level Payout – 5%**

BONUS POOL PAYOUTS – Rise up to higher levels and earn Bonuses on your entire organization to Infinity. In order to receive the higher level bonuses, each position must qualify with the Group Volume as designated below. In order to maintain the particular Active Director status, you must qualify *each month*.

EXECUTIVE DIRECTOR – This position is attained when you have personally sponsored 5 Directors on Autoship in your first line of sponsorship and you have a total Group Volume of \$7,500 in that calendar month through your 5th Level, with no more than 40% from any one leg. You will qualify in a 2% Corporate Bonus Pool, which will be shared with all Executive Directors, calculated on your organizational Group Volume through your 5th Level.

SENIOR EXECUTIVE DIRECTOR – This position is attained when you have personally sponsored 5 Directors on Autoship in your first line of sponsorship, have 2 Executive Directors in different legs in your downline and you have a total Group Volume of \$20,000 in that calendar month through your 5th Level. You will qualify in an additional 3% Corporate Bonus Pool, which will be shared with all Senior Executive Directors, calculated on your organizational Group Volume through your 5th Level.

PRESIDENTIAL DIRECTOR – This position is attained when you have personally sponsored 5 Directors on Autoship in your first line of sponsorship, have 3 Executive Directors in different legs in your downline and you have a total Group Volume of \$50,000 in that calendar month through your 5th Level. You will qualify in an additional 3% Corporate Bonus Pool, which will be shared with all Presidential Directors, calculated on your organizational Group Volume through your 5th Level.

AUTOSHIP – The key to developing a successful networking business is having Directors in your organization making monthly purchases on a consistent basis. The reasons LYC Classic strongly urges every person to participate in the Autoship Program is because it:

- Helps to build a solid, stable business.
- Helps people stay on the products, get results and build belief.
- Helps keep your organization active.
- Helps achieve a long-term stable volume as your organization grows.

AUTOSHIP PAYMENT – All Autoship Enrollment must include a form of payment. You must fill out the complete Credit Card number, expiration date, the exact name used on the Credit Card, correct billing address of the Credit Card, along with the signature of the Credit Card holder. Should your Credit Card expire, you are responsible to let the Company know of the new expiration date or provide a replacement card if necessary.

AUTOSHIP PROCESS DATE – Your monthly \$40 Wholesale Volume Autoship order will be processed each month on the date that you request on the Autoship Application Form (10th, 15th, or 25th). You can order whatever products you wish (which must be for a minimum of \$40 Wholesale Volume in *ONE* order) before the date of your Autoship order and your Autoship order will NOT be processed. Please allow at least 5 days for the order to be received and processed by LYC.

CHANGES/CANCELLATIONS – All Autoship changes or cancellations are required to be submitted to LYC Classic in writing. Any changes such as a form of payment or change of shipping address are required to be submitted in writing.

DECLINED CARDS – When Charge Cards are declined, your Autoship account will be automatically cancelled. If you wish to begin your Autoship again, a new Autoship form must be completed and sent to LYC Classic.

AUTOSHIP RETURNS/EXCHANGES – Returns or exchanges of Autoship packages are not allowed. Any unauthorized Autoship return will result in an automatic Autoship cancellation and an adjustment is made for Bonus payouts.
